NOTIFICATION

In partial modification of the previous notification issued vide Letter No. 3350/AU/CAC/Intern/2021, dated: 02.09.2021.

Based on the deliberations, the following decisions were taken

Mini project / Industrial Training / Internship / Practical Training/ certificate training / summer training / hospital training / creative and innovative project.

The students who need to undergo **Mini project / Industrial Training / Internship / Practical Training/ certificate training / summer training / hospital training / creative and innovative project** and similar such courses of credits ranging from 1-3 as prescribed in the respective curricula, during the sessions mentioned below, shall be permitted to undergo these courses in the form of an **equivalent Mini project / Self study project** of professional nature **in the online mode / physical mode** under the guidance of a faculty member of the concerned department with **ratification or prior permission** from the respective HOD. Alternatively in lieu of the course, they can enroll for an additional professional elective or online course related to professional elective courses (not open elective courses). The students shall undergo this online course through NPTEL courses and shall produce the certificate/ marksheet, after passing the course as per the norms of the offering organization. For NPTEL courses the guidelines issued on evaluation of NPTEL courses on 6.2.2021, shall be followed. **The number of credits transferred from the equivalent course shall be the same as the number of credits prescribed in the respective curricula for the Mini project / Industrial Training / Internship / Practical Training/ certificate training / summer training / hospital training / creative and innovative project, even if the number of credits that are awarded in the equivalent course is higher than that for the Internship Training/ etc.**

If a student fails in such a course, the student shall be permitted to register for an additional professional elective course of 3 credits offered in the ensuing semester/s and for which the number of credits awarded shall be the same as that of the equivalent courses.

This is applicable to the following sessions and for all regulations of the University Departments.

- i. **Summer vacation - May / June 2021**
- ii. **Odd semester - July - Nov 2021**
- iii. **Winter vacation - Nov/Dec 2021**
- iv. **Even Semester - Dec 2021 – May 2022**

This decision has been taken as a one-time measure, due to covid-19 pandemic.
