NOTIFICATION

Additional Subjects to be studied and subjects exempted in respect of students originally admitted in Regulation R2004 (First year Annual Pattern) and Rejoined in Regulation R2008 in Engineering Colleges Affiliated to Anna University Chennai.

It is informed that the candidates <u>originally admitted</u> in the year 2006 and 2007 for B.E / B.Tech degree progromme of study under Regulation 2004 (I Year Annual Pattern) and <u>Readmitted (after a Break / Prevention due to lack of Attendance)</u> in <u>V Semester in the academic year 2010 – 2011 under Regulation 2008</u> have been given <u>exemption for the subjects already studied</u> and have to undergo certain <u>additional subjects</u>, due to the change in regulations.

Similarly the students readmitted in III & IV semester in BE / B.Tech during 2009-2010 onwards have been given exemption for the subjects already studied and have to undergo certain additional subjects, due to the change in regulations.

Accordingly, the details about exemption of subjects and additional subjects to be undergone by such candidates are notified in the Table enclosed. In this connection, following instructions are issued for the information of the candidates.

- Students who have been given exemption for the subjects already studied <u>need</u> <u>not appear for</u> the examination in that subject in Nov./Dec. 2010 or subsequent examinations.
- 2. Students who have been prescribed additional subjects have to undergo and complete the course of study in that subject in the particular semester mentioned in the Table. Such students who have missed doing the subject in the particular semester should complete it, in the subsequent semesters at the earliest possible before the completion of the degree programme.

- The respective Principal has to make necessary arrangements for the conduct of classes to the students who have been prescribed additional course of study within the period prescribed.
- 4. So far, the students were requested to apply to Director (Academic Courses) through the Principal for their additional / exemption of subjects giving details individually and subsequently individual orders were issued. Henceforth, students need not apply individually and the individual orders will not be issued. All the rejoining students (after break of study/ prevention) will have to follow the notification regarding addition/ exemption of subjects issued by Director (Academic Courses).
- 5. The information in the notification may be brought to the notice of all concerned (HOD, course instructor, class advisor, etc) without fail.
- This Table is also applicable to students who will be rejoining in 6th Semester in December 2010 – April 2011 Session & 7th Semester in July 2011 – November 2011 Session & 8th Semester in December 2011 – April 2012 Session.
- 7. This is also applicable to corresponding Lateral Entry students who were admitted originally in III Semester in the year 2007 and in the year 2008 and readmitted later in R2008 Regulations.
- 8. In general this table of addition / exemption of subjects is applicable for all the BE / B.Tech students who were originally admitted under Regulation R2004 (First year Annual Pattern) and later rejoined / rejoining under Regulation R2008 in the forthcoming academic years.
